### 1.0 Background

The Northern Ireland Planning Statistics is an official statistics publication issued by Analysis, Statistics & Research Team within Department for Infrastructure. The Third Quarter 2017/18 Statistical Bulletin was published on 22<sup>nd</sup> March 2018 providing provisional planning statistics for this period. It also provides a summary of Council progress across the three statutory targets for major development applications, local development applications and enforcement cases as laid out in the Local Government (Performance Indicators and Standards) Order (Northern Ireland) 2015.

#### 2.0 Details

#### Development Management Planning Applications

**2.1** Table 1 below provides a summary of performance in relation to the statutory target for major development applications and local development applications for Q3 and provides a comparison of performance against all 11 Councils.

- **2.2** As is clear from Table 1 above, Causeway Coast and Glens Borough Council received the fifth highest number of applications out of the 11 Councils during Quarter 3, and has the second highest number of live applications. This is also reflective of the length of time taken to process local applications being slowest out of all Councils in Q3.
- **2.3** Table 2 below shows the year to date position at the end of Quarter 3 of 2017/18.

- **2.4** The Planning Department continues to maintain its position in the top half of the performance table in terms of applications received and decided. Of note is that even though we have the second highest number of live applications, the percentage of these over 12months in the system is the 4<sup>th</sup> highest out of the 11 Councils.
- **2.5** Although the time taken to progress applications exceeds the statutory target, this is mostly due to ongoing negotiations to resolve issues to achieve a satisfactory proposal that meets planning policies. This is reflected in the percentage of planning applications approved, the 5<sup>th</sup> highest at 94.8% year to date.

Enforcement

**2.6** Table 3 below shows statistics in relation to enforcement in Q3. Of note is that of the cases closed in Q3, 30.2% were as a result of no breach of planning control being identified.

2.7 Finally Table 4 shows the enforcement statistics year to date, with Causeway Coast and Glens succeeding in having the 2nd highest number of prosecutions out of the 11 Councils. Although we have the 5<sup>th</sup> highest number of cases opened year to date we are still meeting the target conclusion time of 70% within 39 weeks.
