1.0 Purpose of Report

1.1 To agree the Schedule of Planning Committee Meetings for 2019.

2.0 Background

- 2.1 At the Corporate Policy and Resources Committee meeting held on 16th October 2018 it was agreed to refer the determination of the schedule of dates for Planning Committee meetings to the Planning Committee as concerns were raised with the current date of the Planning Committee being held the day after the Council meeting.
- 2.2 The day and frequency of the Planning Committee meeting is currently the fourth Wednesday of the month, commencing at 2pm, with site visits taking place on the morning of the Committee meeting. Reconvened meetings are sometimes held on the occasion that the agenda is not complete on the scheduled date.

3.0 Details

- **3.1** Two options have been put forward for consideration and decision by Members.
- 3.2 Option 1 in Appendix 1 provides dates for the Planning Committee meeting to be held on the Thursday after the Council meeting. However, this will require the RDP LAG meeting to be rescheduled to an alternative date.
- 3.3 Option 2 in Appendix 1 provides for the meeting to take place on the third Thursday of the month with a variation to this for April and September as it would result in Council Committee meetings occurring on three consecutive days.
- 3.4 In both options it is proposed that there will be no Planning Committee meeting held in May and July due to local government elections in May and summer recess in July.

4.0 Recommendation

4.1 IT IS RECOMMENDED that the Planning Committee agree either option 1 or option 2.
