1. Nominations to Committees

1.1 Background

Council agreed at its meeting on 26th February 2015 five committees of 16 appointments (using quota greatest remainder).

1.2 Committee allocations

Committees of 16 appointments as shown in Figure 1 below.

5 committees of 16 members = 80 places; Quota per member = $40/80 = 0.5$

DUP: $14/0.5=28$;

SF: $9/0.5=18$;

UU: $7/0.5=14$;

SDLP: $6/0.5=12$;

ALLIANCE: $2/0.5=4$;

PUP: $1/0.5=2$;

IND: $1/0.5=2$

Chairs & Vice Chairs are filled from positions of responsibility, reducing respective party quotas.

Remaining places : UU= 4; ALLIANCE:= 4; DUP:= 3; SF:= 3; SDLP: = 2;
ALLIANCE:= 2; PUP:= 2; IND:= 2
