#### Nominations for All Party Group on Climate Action

We previously wrote to Councils requesting two elected representatives for Northern Ireland's first ever <u>All Party Group on Climate Action</u>.

The Group's purpose is to provide a forum for discussion between politicians, NGOs, business leaders and academics, to drive progress on climate action and sustainable development in Northern Ireland.

Membership of the Group is cross party and includes representatives from the Northern Ireland Assembly as well as elected members from local councils. The Group usually meets monthly on the last Friday of the month, with an Annual General Meeting once a year.

Due to the pandemic most of the meetings have been held virtually, although we are exploring a hybrid approach whereby meetings will occasionally be held in Stormont.

Since its establishment, the Group has met on 10 occasions:

- 24 January 2020 (AGM) Declaration of Climate Emergency (QUB)
- 26 June 2020 Green Growth (DAERA)
- 19 August 2020 Youth Voice (NI Youth Forum)
- 28 October 2020 Climate Change Bill (Private Members Bill)
- 11 December 2020 Low Carbon Retrofit (NI Housing Executive)
- 29 January 2021 (AGM) Nature Based Solutions (RSPB)
- 26 March 2021 Community Energy (Joint Committee on Community Energy)
- 30 April 2021 Sustainable Buildings (Department of Finance)
- 28 May 2021 Sustainable Land Use (Minister for Infrastructure)
- 25 June 2021– Circular Economy / Waste (Minister for Agriculture, Environment and Rural Affairs)

There are some ongoing support costs in relation to providing a secretariat for Group, which are currently covered through council and public authority subscriptions to Sustainable Northern Ireland. There is no fee to participate, however a contribution to the running of the charity would be welcome. We would encourage Causeway Coast and Glens Borough Council to get involved. Councillors are invited to relay key messages and information to internal Committees and Working Groups in order to move this agenda forward and foster national – local dialogue on the need to take ambitious and coordinated action on climate change, before it's too late.

I have enclosed a copy of the Terms of Reference for the Group, for more information.

The next meeting will take place on **Friday 24 September 2021**, **10:00 – 12:00** and will look at the issue of Divestment, with Adam McGibbon of Market Forces and David Murphy, Chief Executive of NILGOSC scheduled as the speakers.

Dear Aidan,

Thank you for your letters of 27 July to DAERA and DfI passing on your Council's motion on a possible Coastal Observatory. I have spoken with colleagues in DAERA and we agreed that I would provide a combined response on behalf of both Departments.

As you will be aware, the Coastal Forum is the mechanism through which work is being progressed to devise solutions to the problems facing our coastline and DfI, DAERA, Councils and the National Trust have worked collaboratively to develop a Coastal Forum Work Programme. The Council representative on the Coastal Forum Working Group (CFWG) may have advised you that at the meeting on 27 April 2021, DAERA officials gave a presentation which explored some initial options for a possible Coastal Observatory in NI. Three main options were highlighted and CFWG members were asked to provide their views on the options. During the CFWG meeting, DfI / DAERA officials did highlight that this was an initial scoping exercise as this was a matter for future policy consideration and there would be significant funding implications.

One of the outcomes of the Coastal Forum meeting on 24 June 2021 was to seek approval from the DAERA and Dfl Ministers to hold a policy workshop this autumn. Subject to Ministerial views, it is expected that potential for a Coastal Observatory will be one of many topics discussed at the workshop, including how organisations would fund same. Another possible topic at the workshop is likely to be future legislation needs. All members of the Coastal Forum and CFWG will be invited to attend the policy workshop this autumn; at this point, we are planning on the workshop being held virtually.

I welcome the continued engagement on coastal management issues through the Coastal Forum and CFWG and look forward to CC& GBC attendance at the virtual policy workshop when your colleagues will be able to contribute to the challenging policy, funding and legislative issues, including discussions on a possible Coastal Observatory.
