Request for a Dog Control Order on lands between Ballintoy Harbour and Whitepark Bay

Council have an asserted Right of Way over the lands as detailed above. This assertion is causing considerable hardship for the landowner who grazes sheep here; there are constant dog attacks on his sheep by irresponsible pet owners who constantly allow their dogs to run out of control. Apart from signage at Ballintoy Harbour, Council have not taken any action to try to stop the cruel attacks on the sheep causing considerable loss to the farmer. Accordingly, I now propose that Council make a Dog Control Order on this land to ban dogs from the area which is a working sheep farm.

In proposing this I am mindful of the need for Council to maintain the good will of all landowners were asserted ROWs cross farmland.
