

- 2.4 Officers continue to be deployed across the Borough, 7 days per week to detect offences with the aim of reducing the amount of litter across the Borough.
- 2.5 Members are reminded that should they wish to accompany any of the officers on patrol to observe first-hand how they engage with the public, that may be arranged.
- 2.6 All those that have been given a FPN have the right of representation directly to the company to challenge the issue. - 2.7 For those who do not have internet access an address for written representations can be provided.
- 2.8 Council officers will continue to work with WISE officers targeting litter hotspots and promoting anti-litter initiatives such as the Butt Ballot boxes, use of litter bins, and the Green Dog Walker scheme.
- 2.9 Litter Composition Report 2019/20 compiled by Keep Northern Ireland Beautiful produced the graphic below which highlights the categories of littered items and the amount of litter that could be on our streets at any one time.



3.0 <u>Recommendation</u>

It is recommended that the Environmental Service Committee recommends to Council to note the above.

W.I.S.E. Easter Cruise Report

1. Team

The WISE team on patrol during the Easter Sunday Cruise consisted of the Operations Manager for Northern Ireland and three WISE Team Leaders.

2. Patrol Outcome

- 34 Fixed Penalty Notices issued 33 for cigarette litter
 - 1 for an alcoholic drink

- 31 Paid to date
- 91% payment rate

General Comments

The Team had a very successful day patrolling Portrush town and interacting with the public. The Police were incredibly helpfully in difficult situations and provided immediate support when needed. The public seemed to be very supportive of the presence of WISE on the ground and actively came up to talk to the team regarding their own areas. All in all WISE believe the day was a complete success both in terms of the number of Fixed Penalty Notices issued and education.
