#### 1.0 Purpose of Report

The purpose of this report is to update Elected Members on the proposed Causeway Coast and Glens Borough Council Elite Athlete Scheme (application pack and guidance notes attached at Annex A). This proposed new scheme will support amateur athletes (involved in a sport recognised by Sport Northern Ireland) who are over the age of 16 and competing at Provincial, National, or International level, which may or may not include a top 10 ranking\*.

\*Where the previously mentioned competition levels are not selected in particular sports, applicants who currently compete at the highest standard of their sport may be considered.

#### 2.0 Background

To date, Council has been scoring Elite Athlete applications against pre-existent legacy schemes prior to the Review of Public Administration (based on the applicants place of residence within the Borough). Although these schemes were quite similar, a preliminary review noted the potential for inconsistencies. Therefore, relevant Sport & Wellbeing Officers' were tasked with researching and developing a specific 'fit-for-purpose' Causeway Coast and Glens Elite Athlete Scheme. Development officers aimed to create a consistent approach which would support local athletes who would be competing at an elite level of excellence in their chosen sport. The officers reviewed and benchmarked against neighbouring Councils prior to developing a draft scheme. The draft scheme was then consulted on internally across all sport and wellbeing functions and amendments made as necessary.

Following this, it was deemed essential to determine if the draft supported equality and would meet the needs of future scheme recipients via an external consultation process. The external consultation asked respondents to review the scheme indicating their opinion on its impact, required amendments and to construct suggestions for improvement. In addition, respondents were asked to review the scheme under the Section 75 equality headings and to detail any inequalities or potential for discrimination the officers had not identified (in the initial equality screening). The subsequent consultation process began on 31 January 2022 and ran for 12 weeks until 26 April 2022.

#### 3.0 Options

The options were:

- (1) No Scheme.
- (2) Maintain the Legacy Schemes currently in operation.
- (3) Create a single new Borough-wide Scheme.

Not having an Elite Athlete Scheme for local athletes was not feasible and as alluded to earlier in this report, maintaining Legacy Schemes has proven problematic and potentially open to discrimination. Therefore, the only realistic option was to devise a stand-alone Causeway wide Scheme.

Consequently, a Causeway Coast and Glens scheme was drafted following (i) a baseline review of the legacy schemes in operation and (ii) those currently in use within neighbouring council areas to create a consistent cross-Council approach.

Upon completion the draft Elite Athlete Scheme was Equality Screened and Rural Needs Assessed prior to consultation. As part of the consultation process Officers' ensured that leisure centre users and members of the public were informed about the consultation at various stages throughout the consultation process via Facebook, Twitter, Council's consultation page and other Council public relations formats. In addition, the officers targeted specific relevant groupings identified by all Sport and Wellbeing Officers, such as Leisure Centre members, Sports Centre clubs & associations, local Sports Advisory Committees, and Governing Bodies & associated clubs who work alongside Council's sports development

section. This was to ensure the consultation had the greatest reach and remained visible throughout the full consultation period.

There were 3 responses to the online survey (the age range of the individuals willing to share personal information was 35 - 54). All 3 respondents felt the draft policy was fair and equal to all Section 75 categories. There were no suggestions for improvement or amendment, regardless of the respondent's disability status, community background/religious belief, political opinion, race, age, gender, marital status, sexual orientation, or caring status (analysis report attached)

#### 4.0 Recommendations

Members are asked to note the above and recommend for approval the Causeway Coast and Glens Elite Athlete Scheme.

This scheme will be reviewed after the first year to ensure there have been no implementation issues and to support the inclusion of any additional sports categorised at the required level. Thereafter a review will occur every two years or earlier if new sport categorisations are received or equivalencies change.

# CAUSEWAY COAST AND GLENS BOROUGH COUNCIL ELITE ATHLETE / GOLD CARD SCHEME

Causeway Coast and Glens Borough Council's Elite Athlete / Gold Card Scheme is an incentive to help support local athletes who are competing at a high level of excellence in their chosen sport. The Council recognises the dedication and achievement of such sportspersons and want to convey their support with the gesture of Elite Athlete / Gold Card Scheme membership that will allow awarded sportspersons complimentary use of agreed Council leisure facilities.

#### AIM

The aim of this Scheme is to give recognition to all sports persons from Causeway Coast and Glens Borough area that have attained Provincial or International level or are National Champions in their chosen sport. Such sports persons will (subject to meeting minimum designated criteria), be admitted to the Elite Athlete / Gold Card Scheme and will be permitted to use on an **individual** basis identified facilities owned and managed by Council on a complimentary basis. This is in recognition of the sportspersons achievements and to support their high level of physical preparation in their chosen sport.

#### **ELIGIBILITY**

- a. Sports persons must reside in the Causeway Coast and Glens Borough Council area.
- b. Sports persons **must** be involved at an **amateur** status only.
- c. Sports persons must be involved in a sport that is recognised by Sport Northern Ireland, see appendix 1 for a comprehensive list (which may be updated from time to time)
- d. Sports persons must be able to demonstrate that they:

Are currently at Provincial, National, or International level in any age category of their sport

Or

*i.* Are ranked within the top 10 (Senior Level) in Northern Ireland in the specified sport

Or

- ii. Are competing at International Level in their sport.
- e. Membership will be reviewed by Council on an annual basis on receipt of an application for membership renewal. On application sports persons must have represented their country within the preceding 12 months.
- f. Proof of representation must be provided by a Governing Body representative confirming the eligibility of the said sports person.
- g. Applicants are permitted to use the leisure facilities at any of the following venues:
  - Coleraine Leisure Centre Swimming Pool and Gym
  - Joey Dunlop Leisure Centre Swimming Pool and Gym
  - Roe Valley Leisure Centre Swimming Pool and Gym
  - Sheskburn Recreation Centre Gym

- Dungiven Sports Centre Gym
- Jim Watt Sports Centre Gym

Applicants must enrol (at their own cost) on an Induction Course and be 16+ years of age.

#### **EQUALITY**

#### **EXCLUSIONS**

Causeway Coast and Glens Borough Council <u>will not</u> ordinarily fund the following under the Elite Athlete / Gold Card Scheme:

- Sportspersons living outside the Causeway Coast and Glens Borough Council area.
- Professional sportspersons.
- Sportspersons under the age of 16

#### **RULES AND ADMINISTRATIVE ARRANGEMENTS**

- a. Application forms are available from and should be returned to: subject to service review
- b. Applications will only be assessed if there is evidence that they fulfil a clearly defined need.
- c. Only complete and legible official application forms will be processed.
- d. Application forms should be completed by the sportsperson and returned with accompanying relevant documentation as soon as possible to the Sport & Wellbeing Development Unit; Sports Development.
- e. Membership of the scheme runs for a duration of 12 months before reapplication is necessary.
- f. All applications will be considered by Council who will be responsible for the assessing and administering of the scheme using the criteria provided thus deciding if an athlete is eligible for membership.

- g. Upon acceptance to the Elite Athlete / Gold Card Scheme all members will receive a membership card. The membership card will entitle the holder to complimentary use of Causeway Coast and Glens Borough Council facilities as listed above until the end of the 12-month membership period.
- h. Memberships will be reviewed on an individual basis annually or where deemed appropriate upon reapplication by Council Sports Development Team.
- i. Elite Athlete / Gold Card cards are non-transferable and must be used exclusively by the individual to whom they were issued. (Any misuse of this card will result in immediate cancellation of usage).
- j. Elite Athlete / Gold Card cards must be shown on each occasion of use.
- k. The Elite Athlete / Gold Card Scheme member may only use the facilities as specified above.
- I. All cards must be returned to Council once they have expired, failure to do so may affect membership of the scheme.

- a. Before completing an application form please ensure that you are eligible to apply and have read this guide.
- b. Please read over the application form before commencing to fill it out.
- c. Please ensure that you have completed the application form in full and remember to enclose information as indicated in the checklist at the back of the application form.
