The Chief Executive undertook a roll call.

The Mayor opened the meeting and extended a welcome to members of the press and public in attendance and provided guidance in relation to Council's Remote Meetings Protocol and audio recordings.

## **1. THE MAYOR'S BUSINESS**

The Mayor stated he had attended 52 engagements within three weeks and invited two Councillors to address Council.

Councillor MA McKillop offered congratulations to Cushendall Ruairí Og Club Under 15 Camogie and Hurling Teams on reaching the All-Ireland Féile Finals, the Hurling team were Champions.

Alderman S McKillop, in her capacity as Council's Veterans Champion; marked the Anniversary of the Battle of the Somme, a poignant date which would be commemorated by Council. Alderman S McKillop reflected on 12<sup>th</sup> June which marked the 40<sup>th</sup> Anniversary of Falklands Islands War, sadly 259 British Soldiers were killed and 777 wounded. Alderman S McKillop stated democracy, liberty and freedoms are enjoyed because of the protection and sacrifices of the Armed Forces; the Ukrainian War a stark reminder that the threat of invasion is real and Armed defences needed.

Alderman S McKillop asked Members to continue supporting the Armed Forces and Veterans, as seen in Banbridge in June on Armed Forces Day and asked Elected Members to pause to pay tribute to all those who had lost their lives serving their Country and its people.

*Council paused to pay tribute.*

Alderman Baird offered condolences on the passing of former Moyle Councillor, Seamus Blaney, she stated he always supported new Councillors coming into the area and the Chamber, a very good friend during her time as a Councillor in Moyle.

Councillor P McShane echoed the comments of Alderman Baird, on the passing of Seamus Blaney, he extended sympathies to the family and to acknowledge and thank him for the work he did.

Alderman S McKillop passed sincere condolences to the family of Seamus Blaney, stating he was a remarkable man.

Councillor C McShane echoed the sentiments of the previous speakers, on the passing of former Moyle Councillor, Seamus Blaney, whose nature helped with relations in Moyle District Council.

The Mayor welcomed Councillor Steven Callaghan; and congratulated Alderman McLean on becoming an Alderman.

**Re: Independent Members to the Northern Ireland Policing Board**

Under Part III of Schedule 1 to the Police (Northern Ireland) Act 2000, the Minister of Justice is responsible for the appointment of independent members to the Northern Ireland Policing Board (the Board). The current term of appointment of three such members will expire in November this year and a further three members' terms of appointment will expire in March next year.

Paragraph 8(2) of Schedule 1 of the Police (Northern Ireland) Act 2000 requires consultation with the First Minister and deputy First Minister, district councils and such other bodies as are considered appropriate before making any appointment of independent members to the Board.

Views were sought by Friday 24<sup>th</sup> June 2022.

Dalradian Gold Ltd has been advised that while the granting of a Mineral Prospecting Licence confers rights on them in respect of exploring for minerals, they must get approval from the Department for any specific exploration activity they may wish to undertake under their licence. They have also been advised that some exploration activities may also require a range of further permissions from the Department and other regulatory authorities such as Councils, Northern Ireland Environment Agency (NIEA) and the Health & Safety Executive Northern Ireland (HSENI) as appropriate.
