1.0 Introduction

- 1.1 Under Section 75 of the Northern Ireland Act 1998 is a requirement that the Council have in place an Equality Scheme which sets out how the Council will meet its obligations under the equality and good relations duties.
- 1.2 An Equality Scheme for Causeway Coast and Glens Borough Council was drawn up in 2015 in accordance with Section 75 and Schedule 9 of the Northern Ireland Act 1998. This Equality Scheme was approved by the Equality Commission on 25th March 2015

2.0 Review of the Council's Equality Scheme

- 2.1 Schedule 9 (3) of the Northern Ireland Act 1998 requires the Council to conduct a thorough review of the Equality Scheme within five years of submission of the original Equality Scheme to the Equality Commission.
- 2.2 A full and thorough review has now been undertaken of the Council's Equality Scheme and no major amendments have been made to the Scheme. A number of minor amendments, however, have been required as follows:
