Mid and East Antrim Local Development Plan 2030 draft Local Policies Plan – Call for Sites public consultation (28 June – 30 September 2024)

The Council's Planning Department have commenced work on the Local Development Plan (LDP) 2030 – Local Policies Plan (LPP). The LPP is the second part of the LDP after the Plan Strategy (adopted October 2023) and will include local policies, including site specific proposals, designations and land use zonings.

As part of the LPP process, the Council is undertaking a 'Call for Sites' public consultation to give landowners, developers and other interested parties an early opportunity to suggest sustainable and available sites within the Council area that they would like to be considered for development as part of the LPP preparation. The consultation will open on 28 June and close at 5pm on 30 September 2024.

Council will publish the information received through this consultation as part of the evidence base for the draft LPP. Those submitting a response are accepting that the Council will publish it and the information within it. Published responses will not however contain any personal details of individuals.
