Re: Causeway Coast and Glens Borough Council: Local Development Plan 2038 - Revised Timetable.

I write in response to your correspondence dated 30th July 2024, as follows:

Clarification of information:

Regarding paragraph 3 of your correspondence, I wish to clarify that it was the Council's draft Plan Strategy (dPS), not LDP Timetable, that was presented and agreed at the Council's 24th August 2022 Planning Committee. The dPS then proceeded to the 1st November 2022 Full Council Meeting for ratification, where the Council resolved to defer it for further discussion and consideration.

Further Work:

Following the November 2022 Council meeting, and at Members' request, a suite of party group meetings, workshops and working groups have been undertaken. Discussions remain ongoing regarding the provision of housing in the Borough, and in particular to the following key aspects of this:

- The evolving housing crisis in the Borough;
- LDP Housing Allocation;
- LDP Housing Distribution; and
- LDP Rural Housing Policies.

In advance of the party group meetings, workshops and working groups (see Appendix 1) planning officials have undertaken a range of research to update the Council's evidence base and to inform discussions with Members.

Evidence gathering and research currently being finalised includes, but is not limited to, the following:

- Analysis of the level of second homes and short term lets in the Borough.
- Collaborative working with Tourism NI on short term lets in the Borough.
- Research into how other jurisdictions are dealing with second homes/short term lets.
- Discussions with government departments and key stakeholders, including:

- DAERA re farming/farm dwellings; and
- NIHE re housing need in the Borough.

This recent evidence is to be presented to Members at our next LDP Working Group which is scheduled to take place on 9th October 2024.

At the request of our Members, planning officials are also in discussion with Ulster University regarding the carrying out of independent housing research on behalf of the Council, to inform the Plan preparation.

Timetable Extension:

The current published timetable was agreed at the Council's 24th March 2021 Planning Committee. The Planning Appeals Commission (PAC) was consulted on the revision and agreement with the Department was received on 13th May 2021. It sets out an indicative dPS publication date of spring/summer 2022, which has now passed.

In addition to the further research and evidence gathering undertaken so far by planning officials, there are reports, appraisals etc, within the Council's LDP document library that will also require updating. This includes:

- Topic-related background papers;
- Sustainability Appraisal (including Strategic Environmental Assessment; and
- Retail & Leisure Capacity Study.

This is required to ensure that the Plan preparation is informed by a robust and up to date evidence base.

This further work has implications for both the dPS stage and subsequent stages of Plan preparation. The Council therefore considers it necessary to make a revision to its published timetable which includes indicative dates for each key stage of the Plan-making process as well as an extension to the (notional) end date (from 2035 to 2038), and to ensure a 15-year Plan for the Borough.

Agreement on Revised LDP Timetable:

Further to the information set out above and in In line with the legislative requirements set out in our previous correspondence, dated 2nd July 2024, the Council now seeks the Department's agreement on the submitted revised timetable.
