Dear Wendy

You will be aware that the Department for Communities has policy responsibility for sport and physical activity in Northern Ireland and as part of this delivers an annual Celebration of Sport event which promotes sporting and physical activity opportunities and encourages young people of all abilities and from different backgrounds to participate in and appreciate the wider benefits of sport.

The Department intends to run a Celebration of Sport event in your Council area in 2024 and would like to offer you the opportunity to become involved in partnership with us. Since 2013, the Department has hosted one event in each of the Council areas, at which young



people from the local schools have been able to try approximately 30 indoor and outdoor sporting activities, including boxing, football, cricket, GAA, hockey, rugby, martial arts, netball, volleyball, canoeing and wheelchair basketball. Each year has successfully seen between 600 and 1500 children (depending on the location) attend these events, and they have universally proved immensely popular, as well as providing an excellent day out and opportunity for the young people to experience a new sport or activity.

In 2024, the Department intends to host the Celebration of Sport at the Joey Dunlop Leisure Centre, Ballymoney and I would like to invite you, as the Council for the local area, to support the Event in partnership with the Department.

If Causeway Coast and Glens Borough Council are willing to partner with the Department in this event, I would ask that consideration is given to provide the venue free of charge. This will enable us to maximise the impact of the event and may result in offering a larger range of sports disciplines for local school children to experience and enjoy.

The Department's delivery team will cover the necessary arrangements including the requisite insurances for the event, provision of all sports coaches (unless your council have specific coaches or sports you would like to invite to participate) and liaise with local schools to secure their attendance.

It is also the norm at the Celebration of Sport events for the Department to provide branded merchandise. This year it is proposed to provide water bottles and drawstring bags to all attendees and as a delivery partner the councils logo would be added to these items.

In addition, through the Department's working partnerships with sport governing bodies and Sport NI we aim to secure the attendance of a number of local world class athletes to act as role models for the school children. It is expected that as at previous events the athletes will attract press attention providing a great opportunity for press coverage for both the council and Mayor.

We are currently in the early planning stages for the Celebration of Sport and I understand that our event co-ordinator, Patrick Wood from <u>TheEventsPros</u>, has already been in touch with some of your team to suggest ways in which the Council could help support the Event.

I would ask that you consider my invitation for the Council to become involved in this fantastic event and would welcome the opportunity to discuss this in more detail with you.
