I would like to thank everyone for the very warm welcome afforded to me and I greatly appreciate the insight in to the work they carry out.

I also held a special reception for members of Ballycastle and Coleraine coastguard who work tirelessly in all conditions to keep people safe. The event provided an opportunity to show our appreciation for everything they do.

From the community, I recognised trauma teddy knitters from the Nimble Knitters group in Ballysally and the Dry Arch Children's Centre in Dungiven. The teddies they make provide real reassurance to distressed children and it was my honour to welcome these talented ladies to Cloonavin and applaud them for their efforts.

This month also saw a very successful Crafters Showcase take place in Flowerfield Arts Centre. This was a great opportunity to celebrate our local makers and encourage businesses to stock local produce. There was a terrific turn out on the night and it was a fantastic showcase of this sector in our area.

# 7.2 Construction of Waste Transfer Station at Letterloan Composing Facility (Item 11)

Alderman Robinson sought clarification as to this new transfer facility, and asked if it was going to replace existing systems and was this going to lead to privatisation and potentially loss of jobs?

The Director of Environmental Services confirmed that this was an addition and not a replacement, and further advised that it may present an opportunity for future reconfiguration. There are no plans for privatisation.

#### 7.3 Harbour & Marina Charges 2019-2020 (Item 12)

Councillor Baird sought clarification on a number of items;

- 1. The new harbour charge increases would these apply to residents of Rathlin Island, as they used their boats, the way other Council residents would use a car?
- 2. Where rates and rebates considered with other similar harbour facilities in Northern Ireland?
- 3. Are the charges being applied on a seasonal or annual basis?

The Director of Environmental Services confirmed that a 5% increase would apply to all harbour and marina charges in the Council area, but that annual costs for Rathlin Island were significantly less. When harmonising fees, other sites across Northern Ireland and Scotland were considered. There is a pricing calendar – Ballycastle, Coleraine, Redbay and Rathlin are subject to a 12 month contract. Portrush and Portstewart - 7 month contract and Dunseverick, Portballintrae and Ballintoy – a 3 month contract
