




Portstewart ratio second to permanent homes 2011 2001

Castlerock ratio second to permanent homes



Fragmentation of community and a diminishing sense of neighbourliness

Leaving residents

Living on streets with few neighbours

With the elderly feeling lonely and isolated

and facing possible related mental health issues

With lone householders dealing with a real fear of crime

With young families having no playmates in their streets

Second home owners are less inclined to contribute to or support the permanent community.

Impact on Community

House prices driven up by more affluent second home owners

Young families cannot afford to buy

Young families moving elsewhere

Or forced to rent

The rent paying the mortgage of the landlord

Portballintrae resident disabled pensioner said:

"I look out my window in winter and see no cars parked in any driveways and no lights in any windows; if I fall getting into my car no neighbours to help. I am alone!"

More land more second homes

Between 2001 and 2011

- In <u>Portballintrae</u> more land was developed, houses and apartments built, the population fell by 133
- In <u>Castlerock</u> **116** new dwellings were delivered with the population falling by 80
- In <u>Portstewart</u> **510** new dwellings were provided and the population only increased by **200**
- In <u>Portrush</u> 618 new dwellings were provided Population only increased by **82**

e.g. Lake District St Ives Channel Islands

Second homes not occupied by owner or tenant as sole or principal residence subject to double amount in council tax

e.g. differential rates in Donegal Considered in Swansea
