4. DEPUTATION - HOUSING EXECUTIVE INVESTMENT PLAN ANNUAL UPDATE 2020

Report, previously circulated.

The Mayor invited NIHE Director of Housing to present to Council.

The Director of Housing presented the main headings within the report, what NIHE had carried out within the last year, and advised he would pass to the Regional Manager regarding investments and achievements of the Borough, assisted by the Area Manager. The Director of Housing advised of a high level approach making sure housing was found to support and provide solutions in the Borough to deliver better homes and ensure sustainable communities.

The Director of Housing advised on the significant changes on how to deliver services during Covid. He highlighted the lockdown period which affected maintenance and now successfully working through a backlog. NIHE continued to accept and process housing applications, applications for homelessness and work with customers with regards rent and payments during this period in a sensitive way.

The Director of Housing referred to a significant announcement by The Minister, NIHE would be reconstituted to allow to deliver new builds and acquisitions, to move into the borrowing market and to update and improve old stock. The Director of Housing advised this required a change in the format of business,

whilst accountable at a local level, the Board and Senior Team had welcomed the Minister's announcement.

The Regional Manager outlined the NIHE programme delivery for the last year and going forward. He advised £33M had been spent in the Borough over various aspects of Housing. Planned schemes had been impacted due to Covid. The Regional Manager provided an overall assessment of the Borough, the population change to an increase above retirement age, matched by a reduction in the working age population and reduction in the number of children and was reflected in waiting lists.

A question and answer session ensued between the representatives and Elected Members.
