# 1. THE MAYOR'S BUSINESS

The Mayor opened the meeting 'Good evening members, I want tonight to pay tribute to 100 year old Captain Sir Tom Moore, The British World War 2 veteran who very sadly passed away today. He captured the hearts of so many of our residents right across the Causeway coast region, many of whom donated to his charitable 100 laps across his garden whilst using his walking frame.

He raised many millions of pounds for our health service, money that no doubt has and will save lives. Many dream of super- hero's but Sir Tom was the nations real life superhero who we will all be forever grateful for the life that he lived well. Thank you Sir Tom. You have done yourself, your family and this Nation proud.

I want to condemn the weekend graffiti attack on St Mary's Church in Limavady. It was very sad to see a place of worship targeted in this way, and such despicable acts serve no purpose. I spoke with Monsignor McCanny on Sunday, and I relayed my solidarity with him as Mayor. I have no doubt that the entire Community is united in their condemnation of this incident.

I want to briefly mention a couple of engagements I have carried out since we were last together. I presented a token of appreciation to Conard McCullough who rescued his neighbour from a house fire and I attended the 'Black Santa' presentation in Ballymoney. My congratulations go to Alastair Coyles for raising such vital funds for five local charities.

I want to offer my good wishes to Paula McIntyre who is the new High Sheriff of County Londonderry. I have no doubt she'll be a fabulous ambassador for the area.

I'm also pleased to confirm that we have now launched our centenary civic gift initiative. Some potential recipients have already come forward, and I look forward to seeing this progress.

Finally I want to remind everyone that we must still adhere to ongoing coronavirus restrictions and health advice. We are indebted to our healthcare workers for their efforts, including those involved in the vaccine roll-out. We can best show our support for them by collectively following the guidance and upholding the restrictions.'

There were no declarations of interest.

#### 4. DEPUTATION – ULSTER UNIVERSITY

The Mayor invited Professor Bartholomew, Ulster University Vice-Chancellor to provide members with an update on the Current Ulster University position.

Professor Bartholomew commencing by acknowledging the disappointing announcement regarding the relocation of School of Health Sciences from the Coleraine Campus to Jordanstown and Magee.

Professor Bartholomew outlined the vision for the University of Ulster including a providing a better sub-regional balance and multi-campus model and gave assurances of a renewed commitment, confirming that the University would continue to be headquartered from the Coleraine.

In terms of numbers the Professor confirmed that there were 4390 students enrolled for the current academic year and confirmed that elected members would be kept appraised regarding students numbers but pointed to underfunding issues and the undergraduate cap which influenced numbers.

A question and answer session ensued between the representatives and Elected Members.

Members spoke of their disappointment concerning the announcement to relocate School of Health Sciences from the Coleraine Campus to Jordanstown and Magee.

At the request of members, Professor Bartholomew provided confirmation as follows:-

- Continued investment in Sports Strategy with plans to extend School of Sport.
- 5.1 million investment in sports facilities is for all students to avail of as well as those outside of the University remit.
- University striving for Bio-medical Excellence
- Plans for School of Veterinary still on target
- University will work with Council and play their part in Growth Deal development
- University would welcome opportunities to baluster the student numbers through collaborative working with elected members.
- Commitment to education and up skilling post pandemic on demand.
- Collaborative agreements including Harry Gregg Foundation, Sports Centres and Colab lab.
- Community engagement ongoing including Riverside Theatre which is a form of community outreach
- School and community liaison ongoing
- Assurance of support to students affected by the pandemic including invoking the hardship fund, issue of laptops and taking a flexible approach with staff and students on a case-bycase basis as required.

The Mayor thanked Professor Bartholomew for his attendance and said he looked forward to continued engagement with the University of Ulster.

# 7. MINUTES OF ENVIRONMENTAL SERVICES COMMITTEE MEETING HELD TUESDAY 12 JANUARY 2021

Chair of Environment Committee, Councillor McQuillan, presented the Minutes.

# 7.1 Dog Fouling (Item 4)

Councillor McQuillan reported being contacted by numerous members of the public regarding the ongoing issue of dog fouling in the Coleraine area and commented that the matter had been raised at committee meetings and inter-agency meetings, where Council Officers, at present, were not in attendance.

Councillor McQuillan asked The Director of Environmental Services to explore employing a firm, at no cost to Council, to manage dog foul penalties as currently he felt that the current compliment of Dog Wardens was not impacting sufficiently to tackle the problems. Councillor McQuillan further commented that other Councils were working with such organisations and that the income from paid penalties was how the company were recompensed for the service.

#### 7.2 The Shops (Sunday Trading etc) (Northern Ireland) Order 1997. Temporary Extension of Sunday Trading Hours (Item 14)

Alderman Duddy referred to email correspondence from the Chief Executive to members on 31<sup>st</sup> March 2020 seeking approval to extend and relax opening hours on a Sunday from 12 pm to 1 pm to enable health care workers additional shopping opportunities.

Alderman Duddy further referred to 'for information' report in 12<sup>th</sup> January 2021 Environmental Services Committee meeting which informed members that there would be a continuation to relax the trading hours for an additional 3 hours between 1000hrs to 1300hrs every Sunday during the calendar month of January 2021. From Sunday 7th February, trading hours will revert to that previously agreed, 1200hrs-1800hrs until further notice.

Alderman Duddy asked for clarification that Officers had delegated authority to amend the Sunday opening hours after 31<sup>st</sup> March 2020 and questioned the wisdom of bringing people out to shops for longer hours, suggesting that Council could be implicit in encouraging the spread of Covid-19.

The Chief Executive confirmed that on the guidance of the Public Health Agency, the short turn around and using delegated powers for emergency response Officers implemented the decision.

The Chief Executive further explained that the purpose of the decision was to spread the window of opportunity, to dilute numbers in premises and enhance social distancing.

Alderman Duddy asked that given the further lockdown to 8<sup>th</sup> March would the decision on opening hours be taken to Committee for consideration by members.

The Director of Environmental Services confirmed, at the request of the Chief Executive that on 7<sup>th</sup> February 2021 the opening hours agreed on  $31^{st}$  March 2020 would be put in place ie 12 noon – 6 pm opening on a Sunday.

Alderman Duddy referred to smaller businesses struggling at present who were not even permitted to establish a click and collect service.

Councillor Knight-McQuillan felt that to extend the opening hours in January instead of pre-Christmas when people were required to do larger and essential shopping was not prudent.

The Director of Environmental Services confirmed that the decision was taken on the advice of Environmental Health Northern Ireland and that the majority of Councils took advice and implemented similar arrangements for January.

# 7.3 Department for Infrastructure, DfI – Rivers Coleraine, (dated 1<sup>st</sup> December 2020) - Re. Information of Rubbish/Debris along Bann River at Christie Park Path Coleraine (Item 15 (i))

Alderman Duddy enquired if progress had been made to determine responsibility for removal of rubbish/debris as per correspondence above and indicated that the matter had been raised at the recent Towns Team meeting. The Mayor suggested that this be tabled at the next meeting of The Honourable Irish meeting.

The Director of Environmental Services agreed to follow this up.

That this council believes it is an opportunity to help rural organisations, local communities and hill farmers within the Causeway Coast and Glens area and all those sectors that fall under the remit of his department that are facing such hard times at present.'

Councillor McMullan was invited to speak in support of the Motion:-

<sup>6</sup>Members I am asking the Council to support my Motion calling on the Agricultural Minister to apply for extra Covid funding. This is on the back of the Finance Ministers urgent call for Ministers to make bids for additional COVID funding. This extra funding could be a lifeline to our farmers and rural community organisations who have all been at the forefront in the response to the Covid pandemic.

Farmers have really felt the brunt of a collapse in demand, especially for beef and lamb but they still have to keep producing, all the time adhering to Covid safety guidelines. Many of these primary producers are our hill farmers in the Causeway Coast and Glens. On top of the fall in demand of their product members, they are now experiencing the additional pressures of having no ANC payment and extra losses due to the decision to halt the transition towards a flat rate of Single Farm Payment entitlements.

Members I believe a scheme could be developed within weeks that would allow the Agricultural Department to make a bid to the Finance Department for this funding to support the hill farmer and other Agricultural Primary Producers impacted. This is an opportunity for our Council who has a large rural community to impress upon the Minister the benefit this additional Covid funding would make to our rural communities here in the Causeway Coast and Glens. We as a Council must not allow this opportunity to pass us by, if we do we will be letting our rural communities down.'

Councillor Chivers was invited to speak in support of the Motion:-

Although the previous allocation of money went to other sectors of the industry eg finishers who take their cattle and lambs to the meat factories where they get a set price, the suckler cow and sheep farmers have also been hit with COVID as they depend on the markets who have strict restrictions placed on them that limits the amount of buyers allowed in, also sellers are not allowed in at all therefore the farmer is unable to get a fair price for their stock. This sector needs to be treated as others have.

Our rural community organisations have been at the forefront of the response to the Covid pandemic. Many of these same organisations are carrying substantial overheads and running costs for buildings that are not currently in use due to the restrictions so they also need help.

And finally the extra funding could also be used in the RDP programme such as additional funding to projects and match funding, to projects that are ready to go, with all statutory approvals in place. We have a number in our Council area that this would benefit. I ask members to support our farm and rural communities and vote in favour of our Motion.'

Members broadly supported the Motion whilst some members felt that it was outside of the remit of Council and should be Stormont led.

#### Amendment

Proposed by Councillor Anderson Seconded by Councillor Scott

That this council calls on the Agricultural Minister as a matter of urgency to apply for additional Covid funding in response to the urgent call by the Finance Minister for such bids. We also call on the finance minister to ensure that funding that has been approved to subsidise those businesses who are waiting payments of grants due to COVID restrictions are speedily expedited.

The Mayor put the Amendment to the Council to Vote 38 members voted For, 0 members voted Against, 0 members Abstained The Mayor declared the Amendment Carried.
