	Summary  Northern Ireland's water resources are managed and protected using a catchment based approach which includes rivers lakes and groundwater as well as coastal and transitional water bodies. The Water Environment (Water Framework Directive) Regulations (Northern Ireland) 2017 requires the production and implementation of a River Basin Manager Plan (RBMP) in six yearly cycles. The River Basin Management Plan takes an integrated approach, identifying those bodies which can be classified as being at 'good or better' status.
