The Mayor welcomed the Independent Advisor and invited her to give an introduction.

The Independent Advisor informed Elected Members that she was delighted to be working with Council. The Independent Advisor informed Elected Members that her work with Council focused on good governance; putting communities at the heart of good governance. Since leaving full time employment the Independent Advisor has been a Member of the Accounts Commission for Scotland which focuses on the Audit of Local Government; the focus is not only on financial audit but also best value; it looks at the duty of best value for Councils and how they go about providing services to local areas. Her role in Causeway Coast and Glens Borough Council to provide support and challenge for the implementation team; to provide support and advice to Elected Members and to provide reassurance to the Department for Communities on the approach and process Council has gone through to progress the recommendations from the Extraordinary Audit.
