### PRIVACY NOTICE

This privacy notice is to let you know how Causeway Coast and Glens Borough Council will look after your personal information.

### Our Standards:

The processing of personal data is governed by the Data Protection Act (DPA) and other relevant legislation. When we ask you for personal information, we will ensure that:

- you know why we need it
- we only ask for what we need
- we protect your information and make sure nobody has access to it who shouldn't have
- we only share it with other organisations when it is lawful to do so
- we don't keep it any longer than is necessary
- it is not made available for commercial use without your permission

### Why Are You Processing My Personal Information?

Causeway Coast & Glens Borough Council is collecting and processing your personal information because it has a legal obligation under the legislation referred to on the registration form attached.

We will use your personal information to enable the processing of your registration and to enable us to comply with our statutory duties.

### What Type of Personal Information Are You Processing?

We will be collecting and processing the following types of personal information – Name, address, phone number, email address etc.

### Where Do You Get My Personal Information From?

We have sourced the information provided by you the individual as part of the registration process including online applications.

### Do You Share My Personal Information With Anyone Else?

Your information will be held by Causeway Coast and Glens Borough Council and we will share your information with other bodies or agencies or between internal Council Departments to comply with our statutory duties or where a data sharing agreement is in place with a third party.

We will not disclose any of your personal information to any other organisation without your consent unless the law permits or we are required to do so by law e.g. Finance Act 2011

### Statutory Register

Causeway Coast and Glens Borough Council where legally obliged to will keep a register which may be inspected by the public. Information on this register includes name and address of food establishment and nature of the food business.

### How Long Do You Keep My Personal Information?

## What Rights Do I Have?

- You have the right to be informed that your information is being processed
- You have the right to obtain access to your personal information
- You can have your personal information rectified if it is inaccurate or incomplete
- You can ask for your personal information to be erased (where there is no compelling reason for its continued processing)
- You have the right to restrict processing in certain circumstances
- You have the right to object to the processing of personal information.

## Information Security
