	Summary			
	Fermanagh and Omagh District Council is proposing a number of changes to the Draft Plan Strategy, following detailed consideration of the representations received during the public consultation exercise held between 26 October and 21 December 2018. The purpose of the consultation is to inform the general public, consultation bodies and interested parties of the Proposed Changes and allow comments if they wish, and to demonstrate for the Independent Examination (IE) that everyone affected has had an opportunity to comment before any recommended change is made to the Draft Plan Strategy by the Planning Appeals Commission (PAC). Ultimately, it will be for the Department for Infrastructure to			

determine whether any amendments recommended by the Planning Appeals Commission should be made to the Draft Plan Strategy.

In considering representations received to the Draft Plan Strategy, and the extent and nature of any proposed change required, account has been taken of Development Plan Practice Note 10 'Submitting Development Plan Documents for Independent Examination' (DPPN 10).

The Schedule of Proposed Changes is accompanied by Addendums to the Sustainability Appraisal, Habitats Regulations Assessment, Rural Needs Impact Assessment and Equality Impact Screening Report.

The consultation period will run for 8 weeks, commencing on Thursday 16 July 2020 and ending on Friday 11 September 2020.
