	Basic compliance checks are carried out on annual monitoring returns (AMRs) submitted by registered charities under the Annual reporting programme. The aim is to ensure that the information submitted complies with the fundamental requirements of charities legislation. When an AMR fails a basic compliance check the Commission contacts the charity trustees to advise where they have not complied with their legal obligations and to provide regulatory advice.				
	In order to improve compliance levels and keep the public informed, the Commission proposes indicating on a charity's register entry whether they have been subject to a basic compliance check. Any charity which fails a basic compliance

check will be provided with guidance by the Commission. Where a charity fails to comply with the regulatory guidance provided, the Commission proposes to change the entry on the *register of charities* to read: Failed.
