### 4.2 Deputy Mayor 2019/20 Year 1

As Nominating Officer for the Democratic Unionist Party, Councillor Callan nominated Councillor S McKillop as his party's selection for the position of Deputy Mayor for Year 1.

\* Councillor Chivers left the Chair and handed the Mayoral Chain to Councillor Bateson who then took the Chair for the reminder of the meeting.

Taking the Chair the Mayor thanked his party for the honour of selecting him as Mayor for first year of new Council term and said that it was significant that Sinn Féin will hold the position of Mayor in the first year of the new Council term following on from the successful year as Mayor of his party colleague, Councillor Chivers. He extended congratulations to Councillor Chivers on her term as Mayor. He noted that this was an honour for him, his party and the people of Bann DEA. He stated that he was looking forward to fulfilling the duties on behalf of the all of the citizens of the Council area. He concluded by extending best wishes to all newly elected members

The Deputy Mayor stated that she was delighted to be appointed to the position of Deputy Mayor and that she would do her utmost to represent everyone from all corners of the Borough. She said this was a year that would see the best of the area being showcased across the world, the Borough would host the 90<sup>th</sup> anniversary of the North West 200 and the British Open would also be held in Royal Portrush. The Deputy Mayor outlined that this year, Council would bestow the Freedom of the Borough on the RAF and see the unveiling of a memorial plinth to mark the service of security force men and women who served in the UDR regiments during Operation Banner. She said that whilst eyes are fixed on the future it is right not to forget the past.

The Mayor and Deputy Mayor were both congratulated by members on their nominations.
