Formal Complaint

My reference to badgers made in my recent objection should read Section 10.28.of the Professional Report. I am particularly concerned at the reference to 'exclusion' and 'setts being closed' this ' under terms of a license issued by NIEA'. This is, as I read it, Is included in the Confidential Badger Report access to which has been denied to me.

As a concerned member of the public, I request an explanation of what is going on. This is a serious situation affecting a protected species which I intend to explore fully with NIEA

I am also xoncerned that the 21 turbines that have been built have been granted permission **under appeal,** as has the permission for a further 8 turbines. 'Of the 32 permitted, only 3 were granted outside the appeal process and only after a precedent has been set for turbines at that location. The extra 11 still to be built at Dunbeg will intensify the visual impact of the development.

Now the current application is leaning on the precedent created at Dunbeg to justify a further extension of development by 8 turbined making a total of 40 turbines in what is acknowledged as a 'sensitive area'. This is overdevelopment, a little by littel approach which could well see further applications for extension which, with the precedent set, will be very difficult to refuse.

Please log this as a further objection to this application.
