

# **Local Development Plan Privacy Notice**

The purpose of this privacy notice is to let you know how we will look after your personal information. It contains the standards you can expect when we ask for, or hold, your personal information. The notice also explains our information management (security) policy.

This Privacy Notice covers the Council's Development Plan Section only, which includes the following work areas:

- Preparation, monitor and review of the Local Development Plan (LDP);
- Conservation Area designation, variation and/or cancellation;
- Tree Preservation Orders (TPOs);
- Building Preservation Notices (BPNs); and
- Any other work as may be required by this section as a function of the Council.

There are, however, a number of standards that apply across all of the Council's functions. Where relevant, you will be directed to the Council's overall Privacy Statement, for further information.

## Why are we processing your personal information?

- To enable the preparation of the Council's Local Development Plan;
- To facilitate public participation in the Local Development Plan process as well as other section functions;
- To ensure compliance with applicable legislation;
- To update you and/or notify you about changes; and
- To answer your questions.

## What categories of personal data are we processing?

- Personal Information: Name, address, phone number, email address and signatures.
- Special Categories: we may, in some instances, process data falling under this category, particularly where it relates to a representation and/or correspondence you have submitted.



The following Special Categories of personal data are deemed 'sensitive' and are given specific protection under current legislation:

- racial or ethnic origin;
- political opinions;
- religious or philosophical beliefs;
- trade union membership;
- processing of genetic data;
- biometric data for the purpose of uniquely identifying a natural person;
- health;
- sexuality and or sexual health.

As a general rule, processing of the types of data listed above is prohibited. However, under certain exemptions, the Council may be allowed to process sensitive personal data, when for example:

- you have made your sensitive data manifestly public;
- you have given your explicit consent; or
- there is a law which governs a specific type of data processing for a specific purpose related to public interest or health.

## Where do we get your personal data from?

- Information provided by you in writing, including your name, address, contact details and signature; and
- Information provided by you as part of our online registration or public consultation process, such as your name, address and email address.

## Do we share your personal data with anyone else?

- Your information will be held by the Council.
- Your information may be shared with relevant Council Officers, where the business and legal framework requires or allows it.
- We may share your personal data with Government bodies, for example, during the preparation of the Local Development Plan and the Independent Examinations into the Plan documents (Preferred Options Paper, Plan Strategy and Local Policies Plan).
- No personal information you give us will be used for commercial purposes.
- If we receive an enquiry under the Freedom of Information Act (FOI) or the Environmental Information Regulations (EIR) we will only disclose your information in accordance with the relevant legislation.
- Please note that your name, address, telephone numbers, email address and signature will
  not appear on the internet or be given out in response to a telephone enquiry, but we will
  hold it on our database.



## Do we transfer your personal data to other countries?

Your information will not be transferred to other countries. However anyone with internet access may view the representations received.

We may be required to share data with the Republic of Ireland in cases where cross-border consultation is required in the preparation of the Local Development Plan. However, your name, address, telephone numbers, email address and signature will not be given out and any data sharing will be in full compliance with prevailing legislation.

Some areas of this site require you to submit information in order to benefit from the Local Development Plan updates we issue, as you have asked to be kept informed.

#### **Local Development Plan: Representations Database**

Under The Planning (Local Development Plan) Regulations (Northern Ireland) 2015 the Council is legally obliged, during the Plan preparation, to make the following documents available for public comment:

- Preferred Options Paper;
- Plan Strategy; and
- Local Policies Plan.

Representations, received during the public consultation stages of the Plan Strategy and Local Policies Plan, must be made available for public inspection, both in hard copy, and on the Council's website. Your name, address, telephone number, email address and signature will not be made public, but we will hold these on our database.

Copies of these representations must also be provided to the Department for Infrastructure (DfI) and an Independent Examiner (a third party) as part of the submission of the Local Development Plan for Independent Examination. A Programme Officer will also have access to this information during the Independent Examination stages of the Plan preparation.

Dfl, the Programme Officer the Independent Examiner will, upon receipt, be responsible for the processing of your data in line with prevailing legislation.

## How long do we keep your personal data?

We will only retain your data for as long as is necessary to process your representation and/or correspondence as part of the Plan preparation or for the purposes of other functions required by this section of the Council. Your information will be disposed of in a secure manner when no longer



needed. The periods for retention of information, specifically relating to Planning, are specified in the Council's Retention Schedule.

Causeway Coast and Glens Borough Council is comprised of a number of internal departments who work very closely in carrying out the Council's business functions. As such, personal data may be internally shared when there is a necessary and legitimate need to do so.
