I'll begin this evening where I left off before – with the first ever NI Year of Food and Drink Awards. I enjoyed a fabulous night at the Culloden Hotel, celebrating the very best of our local producers.

A special mention must go to The Journey to Market programme, Causeway Coast and Glens Food Network, Causeway Coast Foodie Tours and the Naturally North Coast and Glens Market who were all highly commended in their respective categories.

It's fantastic to see our local food industry getting the recognition it deserves. The awards themselves were a great showcase of this, and I was delighted to see some of our local produce on the menu for guests to enjoy.

As you will probably know, I am planning an art exhibition in the Mayor's Parlour which will showcase some of the very talented artists who live in the area. We are fortunate to have such a rich and diverse wealth of talent, and this initiative will help to give it the prominence it deserves. I hope you will all support the exhibition when it opens.

I've had quite a few engagements on the theme of education since we last met, including a very enjoyable visit to St Canice's Primary School in Feeny.
