4.1 (278/16) BBC Filming at Ballintoy Harbour, 28th April 2017

A request has been received from the BBC to film at Ballintoy Harbour for the RHS Chelsea Flower Show on the 28th April 2017. This will consist of an interview, GVs of the location and area and walking shots of Ian Price in the landscape and will be filmed from 10:00 to 13:00 approximately.

A small crew of 2 plus the contributor will be filming the shoot using tripod and camera only.

4.2 (283/16) BBC Filming at Alexander Road, Limavady, 3rd June 2017

The BBC are producing a second series of the daytime programme 'Street Auction'. One of two programmes from Northern Ireland is to be made in Limavady rewarding a local citizen.

The programme makers wish to use the Council owned open space adjacent to Alexander Road, Limavady on 3rd June 2017 for the purpose of a 'street party' where items are sold in a pop up auction or bric-a-brac stalls by Paul Martin (of 'Flog It' fame).

Programme makers will be on site from 8am and away by 5pm, have insurance cover and will provide risk assessments and first aid cover. They will be responsible for leaving the site as they found it at no cost to Council.

5.1 Ref 197/16 and 208/16 - Properties at Main Street Portrush
