## 4. PRESENTATION – ZERO WASTE NORTH WEST – "THE FUTURE IS A ZERO WASTE CIRCULAR ECONOMY"

The Vice Chair welcomed M McCay and J Keys, Zero Waste North West to the meeting.

The Committee were advised that an authentic Zero Waste Circular Economy (ZWCE) was a goal where all discarded materials become resources for others to use. It meant designing and managing products and processes to reduce the volume and toxicity of waste and materials, conserving and recovering all resources, not burning or burying them. It was also an opportunity for the North-West to future proof its economy and become a beacon of best practice within the UK and the Island of Ireland.

The following was highlighted:

- The reasons not to incinerate?
- Comparisons on recycling between Denmark who incinerates and Tresviso, Italy who is committed to reducing residual waste;
- Statistics on blue bin recycling and kerbside sorted recycling

It was noted that international evidence shows that a clear collection system and education around its citizens quickly see the benefits and embrace the transition for the positive difference it makes. One of the key ZWCE pilots on the ground was at Stendhal, the first ZWCE festival in Northern Ireland, whereby vendors selling food use compostable plates, cutlery and containers; cans and plastic bottles are collected separately to go to CAN Can in Ballymoney and cardboard is collected separately, then forwarded to LCDI.

The presenters set out the following invitation:

- As part of NWRWMG join with Derry City and Strabane District Council colleagues to ensure that the outline business case for inhouse waste management infrastructure focuses on a ZWCE approach that maximises recyclite quality;
- Own and drive the culture-shift, the ZWCE as a cross-cutting theme for Economic, Environmental, Health and Social Wellbeing and planning;
- It about circulating resources not generating waste!
- Shift your focus up the hierarchy to prevention and reuse + quality of recyclate
- Be conscious of inertial forces of existing infrastructure providers as a key obstacle to zero waste - this has begun already.

The report set out background information on when the Bye-Laws were established in each of the four legacy Council areas and proposal for phased approach to amend the existing four Bye-Laws and provide a measure of uniformity and consistency in terms of style and substance of the Bye-Laws. The report also set out the procedure for amending Bye-

Laws as governed by the Local Government Act (NI) 1972 to include the following:

- At least one month before application for confirmation is made to the Department of Communities by Council notice of its intention to apply must be given in at least 2 local newspapers and placed on the Council's website
- ii. At least one month before application for confirmation is made a copy of the new Bye-Laws must be made available for inspection at the Council Offices
- iii. Bye-Laws cannot come into operation until they are confirmed by the Department of Communities

In order to have these new Bye-Laws confirmed this sequence of events must be followed otherwise the Department of Communities is unlikely to approve the new Bye-Laws.

It is recommended - that Council agree to review the four existing Drinking in public places Bye-Laws in accordance with the procedure outlined above to produce one Bye-Law for the consumption of alcohol in designated places for Causeway Coast and Glens Borough Council.

The Director of Environmental Services confirmed that it was the PSNI who enforced the Bye-Laws and that the existing signs with legacy council's names would be covered with a new Causeway Coast and Glens Borough Council sticker rather than full sign replacement.

## 13. PROVISION OF SERVICES FOR THE TREATMENT OF BIO-WASTE – EXTENSION OF CONTRACT

The Committee reviewed a report seeking permission to extend the Biowaste contract for the collection and treatment of kerbside collected organic waste. Contract was procured by North West Region Waste Management Group (NWRWMG) on behalf of its constituent Councils.

The initial contract was approved in August 2017 for a period of two years, commencing 1 October 2017 and terminating 30 September 2019. The extension period would be for a further 12 months, commencing 1 October 2019 and price per tonne tendered will be unchanged.

**It is recommended** - that the Environmental Services Committee recommends to Council the extension of the Biowaste contract for a further 12 months.

The Director of Environmental Services advised that the contract renewal process would commence in approximately in 6 months' time to ensure the new contract is in place at the end of the 12month extension.

#### 26. AFFORDABLE WARMTH SCHEME FUNDING 2019/2020

The Committee received an information report to advise members with respect to the current position regarding the Department of Communities Affordable Warmth Scheme.

The Department for Communities (DfC) by letter dated 4 April 2019 confirmed that the overall capital budget for the current year was £12M reducing from £15M the previous year. The average spend per household has now risen to £4500.00

The reduced budget and the higher average spend has resulted in the acceptance of fewer referrals from Councils in the current year. As a consequence a total of 216 referrals are requested over the 12 month period equating to a total funding being paid of £41,256.00. Staffing levels have been reduced to reflect the decrease in funding received. In addition, the DfC have advised that they have asked the NIHE to temporarily delay the issuing of approvals for applications to the scheme. This delay will affect all applications across Northern Ireland (approximately 900) received since 31 December 2018 and an additional 400 received prior to this date. The reason for the delay is a scheme approval issue which prevents expenditure against the schemes available budget.

NIHE are continuing to make payments for approvals already issued on completion of the work. The NIHE are to contact all those that have outstanding applications to update them on the latest position and apologise on behalf of the DfC.

On the 16 May 2019 correspondence was received from DfC advising that it has now received approval for progressing extremely urgent cases only.

These are defined as-

- 1. applications received from those with a disability or serious illness and without an operating central heating system; or
- 2. applications from those who are frail elderly (aged over 85) and without an operating central heating system.

Council were further advised that NIHE will now begin issuing approvals for applications received that meet the criteria as above. A request has been submitted to DfC as to the impact this change in criteria will have on referrals already made, together with those from this date forward. Further information will be provided when this is available.

Several Members voiced concern at the reduction in budget and to the impact this would have on the most vulnerable.

#### 27. THE STREET TRADING ACT (NI) 2001

The Committee received a report to update Members with respect to the decision by Council to refuse a Mobile Street Trading Licence and a subsequent Prosecution for Illegal Street Trading of that applicant.

Members noted that a confidential report Item 18, considered at the Environmental Services Committee 181119. At that time the Committee

and subsequently Council decided to refuse to grant a Mobile Street Trading licence to an applicant on the grounds that:

"The applicant is on account of misconduct or some other reason relating to trading activities, unsuitable to hold a mobile street trading licence".

This decision was taken as the applicant had been successfully prosecuted by Council on 6 October 2017 for Illegal Street Trading in an ice cream van in Kilrea. The applicant was fined £250 plus legal and court costs and an offender's levy imposed.

The applicant was informed of Council decision to refuse to grant him a Mobile Street Trading licence and subsequently appealed the decision of Council to the Magistrates Court.

Following receipt of complaint from the public, an Officer from the Council's Licensing Team undertook a patrol of the Kilrea area on 6 December 2018 to monitor for illegal trading. The Officer noted street trading from an ice cream van and the matter was recommended for prosecution. The matter was heard at Coleraine Magistrates Court on 3 May 2019.

The defendant pleaded guilty and a fine of £250 was imposed together with costs.

As a consequence of this conviction the Judge decided to also deal with their appeal to Council's decision to refuse to grant them a Mobile Street Trading Licence (Item 18 181119 as referenced above). The Judge dismissed that appeal.
