	<p>DAERA is seeking to review the Department's current Area Based Schemes Review of Decisions Procedure. In particular, they want to replace the current procedure with a process which better meets the needs of farmers and which brings about a timely outcome of the Decision they have asked the Department to review.</p> <p>The Department currently operates a two stage process; Stage One is an internal review, which can be followed by a Stage Two review if the applicant remains dissatisfied with the outcome of Stage One. The current Stage Two review includes a hearing by an external panel which make a recommendation to the Head of Paying Agency.
