# Erratum LA01/2016/1391/O Outline Permission

Corrections to remove the refusal reasons in relation to ribbon development. Paragraph 8.14 and refusal reason 4 from the report and amend paragraphs 8.1, 8.17 and 9.1 after a further consideration of the application.

# Remove paragraph and refusal reason 4 below:

8.14 CTY 14 states that a new building will be unacceptable where it is unduly prominent in the landscape, it would create or adds to a ribbon of development under CTY 8, or the impact of ancillary works would damage rural character. This proposal would lead to ribbon development along Carragh Road and will have a detrimental impact on rural character, therefore this proposal is contrary to policy CTY 14.

## Refusal Reason 4

4. The proposal is contrary to Paragraph 6.77 of the SPPS Policy CTY 8 and CTY 14 of Planning Policy Statement 21: Sustainable Development in the Countryside in that the buildings would, if permitted, would create a ribbon of development along Carragh Road and result in a detrimental and unacceptable change to the rural character of the countryside.

This paragraph should read,

9.1 The proposal is considered unacceptable in this location having regard to the Northern Area Plan, and other material considerations, including the SPPS. It fails to meet the principle policy requirement of PPS 21 for a dwelling in the countryside, and fails to meet the requirements of Policy CTY 10, 13 and 14. Refusal is recommended.
