1.1 Application

The Environmental Services Department is in receipt of an application from Mr Danny O'Kane, 68 Broomhill Park, Coleraine. Mr O'Kane is the husband of the late Mrs Judith O'Kane who held 1x Stationary Street trading licence for Lansdowne. Mr O'Kane has made application for the licence which was in the name of his late wife. The late Mrs Judith O'Kane had been a Stationary Street Trading licence holder at Lansdowne since the inception of the Street Trading Act (Northern Ireland) 2001. The business trades as Barts Ices and has been trading for over twenty years within this Borough.

1.2 Options for Resolution

- a. Refuse the application by Mr. D O'Kane for the Stationary licence at Lansdowne.
- b. Grant the Stationary licence previously held by the late Mrs J O'Kane to Mr D O'Kane.

Members may recall approving the report in February 2016 recommending that Committee authorise 'the intention' to consider a rescinding designation with respect to the 4 No. Street Trading Pitches at Lansdowne, Portrush.

1.3 Recommendation

Considering the circumstances surrounding Mr O'Kane's application and the proposal to rescind designation of these pitches at Lansdowne it is recommended that committee authorise the Stationary Licence at Lansdowne to be issued to Mr O'Kane for 1 year pending the de-designation of the pitches at this location.
