The purpose of this report is to provide Members with information regarding the Causeway Coast and Glens Local Policing Plan for 2016-2017.

Local Policing Plans which set out the arrangements for the policing of each police area are issued by District Commanders. Local Policing Plans provide the opportunity for Police Commanders to consult with their PCSP to ensure that police are responsive to the needs and concerns of local communities. Local PCSPs monitor the performance of the local policing area through PCSP meetings, some of which are held in public. Although Local Policing Plans are published separately, they are consistent with the Northern Ireland Policing plan.

The Causeway Coast & Glens Local Policing Plan for 2016-2017 (Annex A) is attached for information. Local priorities are to reduce the levels of drug activity, reduce the levels of anti-social behaviour and to reduce crime, particularly the number of domestic burglary. The PSNI will deliver services in partnership with the Policing & Community Safety Partnership and publically report on progress.
